 - 2 Charges of Professional Judgment

Miscellaneous:

- New Vice President -
 - In a motion by Dr. Callahan, and seconded by Ms. Chaput, the Board voted unanimously to appoint Dr. Christine Calvert as the Vice-President of the State Board of Veterinary Medical Examiners, replacing the vacancy left by Dr. Karena Joung.
- Dr. Parsons Inquiry
 - Dr. Parsons would like to volunteer for Daughters Pony Club as a Veterinarian to monitor the horses TPRs. Would she need a veterinary license to do this?
 - Could do triage but not prescribe couldn't do more than first aid.
- Jenn McMahon Inquiry
 - Can expired medications be used for euthanasia?
 - o Expired medications can not be used to euthanize an animal.

- This regulation is only for the disposal of medications and only for animal control facilities and is not an acceptable method to dispose of expired medications in regular veterinary practices.
- Dr. Melissa Rudo Request for an extension for CEs.
 - In a motion by Dr. Reed, and seconded by Ms. Quimby, the Board has voted to allow an extension of 10 days.
- HB325/SB290 Changes -
 - Removal of Transcript Requirement for License Applications from Other
 Jurisdictions has been Implemented. Efforts will be made to update information in
 the portal after registration renewals complete and work begins on changing to
 OneStop.
 - Staff approvals by designated authority with no history of violations or criminal records has begun and is going smoothly.
 - Update on NAVLE Retake Alternatives -
 - The Board reviewed the licensing requirements regarding NAVLE score usage in other jurisdictions and the examination requirements of the allied health fields in Maryland.
 - DC License with Mentorship Program as an alternative
 - MD ADEX (Dental Board) No ADLEX Examination Expiration
 - Physicians Requirements Examination Scores >15 years
 Requires SPEX Exam specific to physicians returning to the field.
 No comparable exam exists for Veterinary medicine.
 - Board to consider a mentorship program after further discussion.
 - In a motion by Dr. Reed, and seconded by Dr. Callahan, the Board voted to change the regulation to allow NAVLE scores to be valid for 7 years (current regulation allows for 5 years).
- Final approval of ACF regulation changes Chapter 4
 - In a motion by Dr. Callahan, and seconded by Dr. Reed, the Board voted to accept the animal control regulations as written.

Dr. Callahan adjourned the meeting at 12:15 pm.
