Miscellaneous:

- Amanda Abell from VCA Park Animal Hospital submitted an inquiry to the SBVME requesting an allowance to provide prescriptions for a neighboring VCA hospital that is temporarily closed due to no Veterinarian.
 - The hospital has access to the other clinics records.
 - Board allowed for the hospital to provide prescriptions for 3 months while a veterinarian is located. They must still review the medical records and agree with the prescribing of the medications.
- PDMP informed the Board that they will not be submitting legislation proposals to require veterinarians to report the dispensing of controlled substances.
- Letter of Good Standing Change to Digital Only
 - A new form will be used that will require veterinarians to provide E-mail addresses for where the Letters of Good Standing will be sent. Letters will be sent to the desired recipient and the requesting veterinarian.
- Dr. Radue presented information from a California vet board case that was requiring VCPR/Exams be established by veterinarians at race tracks before dispensing medications.

In a motion by Dr. Calvert, and seconded by Dr. Reed, the Board voted unanimously to adjourn the meeting to move into an administrative closed session to perform administrative functions outside the scope of the Open Meetings Act, in accordance with § 3-103(a)(1)(i) of the General Provisions Article. The administrative functions to be performed include discussion of the specific matters identified on the Board Agenda. In the alternative, I move to close the meeting pursuant to the following Section 3-305(b):
